



## LAKE COUNTRY POWER Commercial LED Lighting Retrofit 2026 Rebate Application



### Rebate Requirements - rebate will not be processed without the following:

- ☐ All lighting installed to code and operational at time of rebate application.
- ☐ Rebate is submitted with a copy of Invoice including labor, materials, and total project cost.
- ☐ This rebate is only available to commercial members.
- ☐ Type of light being installed, replaced, wattage, and hours of use are filled out.
- ☐ Application must be submitted by December 31st, 2025.

**Rebate Amounts:** All lighting rebates are calculated per project and will be based on the kWh savings and are subject to rebate fund availability. Rebate will not exceed fifty percent of total project cost.
